Particular Experience in Distribution Arbitration

Distribution Agreement Arbitration: A German distributor has acted as the sole distributor of a Turkish producer of fiberglass. The German distributor was in default in the payment of the purchase price for the products supplied and the Turkish producer has terminated the distribution agreement and claimed the unpaid amounts. The German distributor as a counter-claim requested the payment of good-will indemnity. The case is handled by the sole arbitrator under ICC rules. The claim is accepted and the counter-claim is rejected.

Agency Agreement Arbitration: a Swiss company acting as the agent of a major Turkish cement manufacturer claimed its unpaid commissions in a case initiated in accordance with the ICC Rules. The parties have settled after the hearing.

Distribution Agreement Arbitration: a Turkish company acted as the sole distributor of an Italian manufacturer of tractors. The Italian manufacturer terminated the distribution agreement for not achieving the minimum targets. The Turkish distributor sued the Italian manufacturer for good-will indemnity. The sole arbitrator appointed in accordance with ICC rules rejected the case since the applicable Italian law does not allow good-will indemnities for distribution.
